**Driver Class move up:** Heath Dry would like to discuss Article 5:1.H in the QMA rule book. If a driver has not completed 12 months in a lower class or combination of a lower class (not including novice year) Our club needs to make sure the Novice Committee gives unanimous approval with the final approval from our Regional Director before a driver can move up to 160, B, AA, or WF.

**Medical red on the track:** Roger Dry would like all of our members to be aware that it is their option to call 911 when their driver is hurt on our track.

**Power Broom:** Roger Dry suggested we demo a power broom at our track.

**No Signaling to drivers:** The Race Director will have the authority to immediately disqualify a driver/car for signaling by Handler to Driver (under green flag conditions) sec 4: 21.A4. Race Director disqualification's may not be protested. Sec 4:21.B

**Tires:** Contact Troy Thompson (602) 576-5409 if you would like to purchase new Vega or Hoosier tires.

**Judging:** Curtis Pyle would like to encourage all members to read up on their rules. It is very important you understand the rules before judging a race.

**Helmets:** Please remember there are no skins or tape allowed on helmets. Visors must be down when practicing, hot lapping, and under green flag conditions.
